### FIELD OF STUDY **LAW - MANAGEMENT**





The Civil Law system is one of the most widespread legal systems in the world, and much like the Common Law, it owes a lot to the French system.

French law has inspired many foreign countries. Studying law in France thus allows students to discover the roots of the system in place in their own country, and for those who come from a country under the Common Law, it enables them to discover the "other" legal system.

The way law is taught in France privileges critical thinking and reflection on what law is, but also on what it should or could be. Students need to acquire a solid knowledge base in order to reason on law and question its methods and forms.

Over time, the Rule of Law has been modified, transformed, replaced. Just as knowing it is a necessity, so too is being able to comment on it, analyze it and criticize it, in order to be able to understand what a new rule brings to the table and the challenges it represents.\*

This vision of law studies in France enables students to work in fields other than legal careers (judge, lawyer, magistrate, notary, court clerk, bailiff, etc.). Students can also choose a career in administration, as executives in the private sector (legal expert in a company, in social law, environmental law, in banking and insurance, etc.) or in public administration, for professions that require expertise in dealing with issues in the legal, administrative, human resources fields, etc. at a national, European and international level.

Law is mostly taught in universities. Its evolution, its application in everyday life and its new related fields altogether ensure training in judicial careers, as well as in legal expertise in all sectors. More than forty Law faculties offer numerous specialized and multidisciplinary courses, where law is taught in relation with another field.

# International

France belongs to the Council of Europe Programme on Human Rights Education for Legal Professionals (HELP), which aims to train more judges, lawyers and prosecutors in the 46 member states of the Council of Europe. It promotes the application of European standards in human rights and offers HELP online courses that cover a wide range of subjects related to human rights.

The French National School for the Judiciary (ENM) is a founding member of the European Judicial Training Network (EJTN) and of the Euro-Arab Judicial Training Network (EAJTN), and is a member of the International Organization for Judicial Training (IOJT). The HELP program brings together representatives of training institutes from 46 Council of Europe member states to harmonize training on the standards of the European Convention on Human Rights (ECHR).

The ENM supports judicial training institutes and trains French and foreign magistrates for international work. Through bilateral and multilateral collaborations, it provides its partners with expertise in educational engineering, professional practices, e-training, international matters, and research.

### INTENSIVE COURSE: CLASSE UNIVERSITAIRE PRÉPARATOIRE AUX GRANDES ÉCOLES (CPGE)

2 YEARS OF HIGHER EDUCATION – L2

The preparatory class in Economics and Management, option Economics, Law and Management is offered in *Lycées* (high schools) and can be done in one year at ENS Rennes.

### **BREVET DE TECHNICIEN SUPÉRIEUR (BTS)**

NATIONAL DIPLOMA – 2 YEARS OF HIGHER EDUCÁTION – L2 120 ECTS credits

The **BTS Collaborateur Juriste notarial** (advanced technician's certificate in legal and notarial collaboration) trains notarial assistants to draw up deeds or to act as negotiators for sale or rent, to work in a notary's office, to assist the notary in carrying out certain tasks as an assistant in drafting deeds (marriage contracts, donations, inheritance, residential leases, etc.) and ensure their administrative compliance, or to act as a negotiator in real estate, in sales or rent.

### DIPLÔME D'ÉTUDES UNIVERSITAIRES SCIENTIFIQUES ET TECHNIQUES (DEUST)

NATIONAL DIPLOMA – 2 YEARS OF HIGHER EDUCATION – L2 120 ECTS credits

The **DEUST Assistant juridique** (legal assistant) is run by the *Institut Sociétés et Humanités : Droit et Administration publique* of the Polytechnic University of Hauts-de-France (UPHF).

#### LICENCE

NATIONAL DIPLOMA – 3 YEARS OF HIGHER EDUCATION – L3 180 ECTS credits

The *Licence* can be followed in faculties of **Droit, économie et gestion** (Law, Economics and Management) with a major in **Law** in about fifty universities. It is also possible to enroll in a double degree, *Licence et Diplôme Universitaire (DU)*, which links law with computer science, economics, sciences and innovation.

### LICENCE PROFESSIONNELLE (VOCATIONAL BACHELOR'S DEGREE)

NATIONAL DIPLOMA – 3 YEARS OF HIGHER EDUCATION – L3 180 ECTS credits

It is carried out by faculties of **Droit, économie et gestion** with majors in **Law** and **Activités juridiques** (Legal Practice), with about forty specializations: Litigation and Collection, Law and Business, Environmental Law, Law and Management, Real Estate Law, Heritage Law, Private Law, Social Law, Public Procurement, Notarial Professions, etc. The major in **Métiers du notariat** (Notarial Professions) offers a wide range of possibilities within various organizations and local authorities.

### **DIPLÔME UNIVERSITAIRE (DU)**

3 YEARS OF HIGHER EDUCATION

Within law studies, it is possible to enroll in the **DU Criminologie** after two years of higher education and to achieve it in one year in five French universities. However, in France, criminology is considered as a specialization and training in the field does not award any official title or degree.

### MASTER

NATIONAL DIPLOMA – 5 YEARS OF HIGHER EDUCATION – M2 120 ECTS credits

It can be prepared within a **Droit, économie et gestion** program with different majors that encompass several specializations: Comparative Law; Communication and ICT Law; Property Law; Banking and Finance Law; Canon Law; Civil Law; Economic Law; Corporate Law; Environmental and Urban Law; Real Estate Law; Intellectual Property Law; Health Law; Maritime Law; Business Law; Insurance Law; Rights Law; Digital Law; Heritage Law; Law and Management of Wine and Spirits; European Law; Tax Law; International and European Law; Notarial Law; Criminal Law; Private Law; Public Law; Social Law; Human Rights and International Justice; Law and Economics; History of Law and Institutions; Justice, Trials and Procedure.

The **DU Diplôme de juriste conseil d'entreprise (DJCS)** (legal counsel for companies diploma) is accredited nationally by the *Fédération nationale pour le droit de l'Entreprise*. It can be done in a dozen Universities and is accessible to those who already did one year of master's in law.

### LICENCE

NATIONAL DIPLOMA – 3 YEARS OF HIGHER EDUCATION – L3 180 ECTS credits

These *Licences* are especially adapted to the evolution of law and to specialization. They are highly demanding and selective, and allow taking courses in two more majors during six semesters until the *Licence* level is achieved. From the first year, law is taught in relation with other fields: biotech medicine, political science, economics, social sciences, art history and English/law-political science. ## NATIONAL DIPLOMA – 5 YEARS OF HIGHER EDUCATION – M2 120 ECTS credits

The programs cover comparative and applied law in different fields: **Common Law** and Comparative Law, Comparative Business Law, European Labor Law and Science, French and Foreign Law, International and Comparative Law, Health Law, etc.



### DIPLÔME SUPÉRIEUR DE NOTARIAT (DSN) 1 YEAR OF HIGHER EDUCATION

The DSN is a national diploma that leads to the profession of notary, which is regulated in France, and it does not automatically give out the title of Notary or Assistant Notary. A notary's expertise in law covers all subjects. Notaries are high-level legal experts specialized in advising individuals and companies in family law, heritage management, real estate law and rural law. The DSN is provided by about twenty universities and is accessible to students holding a Master's degree or an equivalent in Notarial Law.
